Social Security reverses course, will allow parents to register newborns at hospitals

The agency sparked an outcry with its directive that parents register at one of eight Maine offices rather than filling out a hospital form. Critics blasted the move as burdensome and inefficient.

The Social Security Administration reversed course Friday, rescinding a directive that required Maine parents of newborns to register their children at Social Security offices instead of filling out a form at the hospital.

The mandate was widely panned as being cumbersome, unfair and inefficient, and would have caused some parents to have to drive hours for an appointment to get a Social Security number for their child.

The directive also would have terminated electronic filing of death records at funeral homes.

Acting Social Security Administration Commissioner Lee Dudek issued a public apology letter Friday, less than one day after the change was first reported by the Press Herald and Lewiston Sun Journal.

Gun safety advocates get red flag proposal on fall ballot

Judge orders state to drop charges, release some from jail amid long waits for lawyers

In April, Maine must begin releasing those who have gone more than two weeks without legal representation, and prosecutors will drop charges for those waiting more than two months.

Maine will start releasing people from jail in April if they have waited more than two weeks for a lawyer, a judge ruled Friday.

Additionally, charges other than murder will be dropped against anyone who has waited more than two months for a lawyer. Those charges

could be brought again once an at-

torney is available. These unprecedented remedies were ordered by Superior Court Justice Michaela Murphy after she recently found that the state has violated the constitutional rights of hundreds of criminal defendants

Wood renowned: Furniture maker Thomas Moser dies at 90

He founded Thos. Moser Cabinetmakers in 1972 out of a garage in New Gloucester and went on to create furniture for popes and presidents.

Thomas Francis Moser, Maine-based craftsman known for the elegant wooden furniture that bore his name, died Wednesday, his family announced Friday. He was 90.

Moser founded Thos. Moser Cabinetmakers in 1972 out of a garage in New Gloucester, his family said.

Today, Thos. Moser employs more than 60 craftspeople in its Auburn workshop, where it has been headquartered since 1987, the company said. In January, the Moser family

sold the company to Portland-based Chenmark holding company, said CEO Philip Hussey, who took over at that time.

"This happened Tom's blessing, in that he wanted to find a way to make sure that Thos. Moser could continue on for the next 50 years," Hussey said in a phone call Friday night.
